## Important Disclosure

### [Required of All Correspondence/Distance-Education Law Schools in California]

**The Bar Program - Juris Doctor Degree:** The method of instruction at this law school for the Juris Doctor (J.D.) degree program is principally by correspondence.

Students enrolled in the J.D. degree program at this school who successfully complete the first year of law study must pass the First-Year Law Students' Examination required by Business and Professions Code Section 6060 (h) and Rule 4.55 of Title 4, Division 1 of the *Rules of the State Bar of California (Admission Rules)* as part of the requirements to qualify to take the California Bar Examination. A student who passes the First-Year Law Students' Examination within three (3) administrations of the examination after first becoming eligible to take it will receive credit for all legal studies completed to the time the examination is passed. A student who does not pass the examination within three (3) administrations of the examination after first becoming eligible to take it must be promptly disqualified from the law school's J.D. degree program. If the dismissed student subsequently passes the examination, the student is eligible for reenrollment in this law school's J.D. program, but will receive credit for only one year of legal study.

Study at, or graduation from, this law school may not qualify a student to take the bar examination or to satisfy the requirements for admission to practice in jurisdictions other than California. A student intending to seek admission to practice law in jurisdictions other than California should contact the admitting authority in that jurisdiction for information regarding the legal education requirements in that jurisdiction for admission to the practice of law.

**Significant Note:** Students disqualified from continuance in the school's law study program for not having passed the California First-Year Law Students' Examination within three (3) administrations of the examination after first becoming eligible to take it are, nonetheless, eligible for conferment of the **Northwestern California University Bachelor of Science in Law (B.S.L.) degree** upon successful completion of two years of study with a cumulative grade point average of 2.0. As to students who are already bachelor degree holders, they are eligible to earn the school's B.S.L. as a second bachelor's degree. Completion of the degree signifies critical awareness of the common law legal tradition of the United States and the ability, as a non-lawyer, to apply analytical and problem-solving skills in a variety of legal and non-legal settings.
